## 7. Action Item Update

Ogdensburg Instrument Approach Procedure – The Ogdensburg Airport has hired a new Airport Manager. Dean has introduced himself via email, and the new AM has begun posting NOTAM's for glider training at Dean's request. A new approach plate was published in July by the FAA. The new approach has raised the minimum height to 3100' and removed the direct overflight above the BRTA. Committee notes that this is an improvement, but that a safety concern still exists in the Brockville area, particularly over the St. Lawrence River. Dean will discuss the approach procedure with the Ogdensburg AM.

Reticle Operations Discussion – Matt details new survey work completed along the north boundary, and the proposed additional 10 feet of land clearing. Matt noted that safety discussions are scheduled for in advance of rifle season to ensure a smooth deer hunting operation in November. Matt notes that driver training has been permanently shifted to Brockville. Matt noted that Reticle is working through a noise abatement plan with the MOECP to ensure that all regulations are followed.

#### 8. New Business

Airport Commission Term Extensions – All members confirm intention to continue for next 4 year term, beginning December 2018.

Fuel System – Kent notes the benefit of updating the fuel system. Kent notes that a self-serve kiosk would increase fuel sales, as pilots could fuel at night when no staff is on site. Kent notes that a single point system would allow for fueling or larger corporate jets.

# ITEMS PERTAINING TO AVIATION SAFETY AND AERODROME SECURITY

1. Oct 6, 7 and 8, a Brockville NOTAM was issued, through NAVCANADA and also an Ogdensburg NOTAM was issued, through the FAA, that described gliding activities at the airport. No issues or safety concerns were recorded during the Air Cadets' program.

# ITEMS PERTAINING TO AERODROME MAINTENANCE AND EQUIPMENT

- 1. Oct 10, a City staffmember replaced a light at the Airport Maintenance Garage. He also checked the back door of the Heritage Kitchens for the source of a water leak. The resealing of that door was then contracted out. Parts, for the heater in the Heritage Kitchens building, are on order; however, warm air is being provided by two heaters.
- 2. Oct 17, the Airport Manager conducted an inspection of the NonDirectional Beacon site. No faults were found.
  - 3. Oct 29, the City owned Construction Heater, used in the Airport Maintenance Garage failed to operate. It had been in service for approximately 22 winters. A new, replacement heater was purchased and installed for the purpose of keeping the room temperature above the freezing point.
  - 4. Oct 30, the floor drain, in the Airport Maintenance Garage, was cleaned and flushed.

## **GENERAL REMARKS**

- 1. Oct 3, 4 and 24 the Reticle Ventures Canada shooting range was active.
- 2. Oct 11, Reticle Venture Canada chartered a Voyageur Airways DHC 8 to ferry students to its' training area. The aircraft's photo was later published in the Brockville Recorder and Times newspaper.
- 3. Oct 23 and 23, Reticle Ventures Canada conducted another exercise in its' training area.
- 4. Oct 27, the crew of an Allegiant Air Airbus A320 announced its' position and intentions on the Brockville Aerodrome Traffic Frequency. While such a call is not a requirement and is seldom given, it was welcomed.
- 5. Oct 31, two local hunters signed waivers that allowed them to harvest deer from the airport property. The APM attended a meeting, with other stakeholders, to discuss where the hunters are permitted to travel. A verbal report will be provided to the members of the Airport Commission at the November 20<sup>th</sup> meeting.
