## 7. Action Item Update

Ogdensburg Instrument Approach Procedure - No Discussion

Reticle Operations Discussion – Kent notes that a number of sea containers have been installed for noise abatement purposes, and that he has confirmed these structures do not require a light. AC notes that there are a number of vehicles scattered around the Reticle Campus area, and Kent notes he will speak with Reticle to have the area cleaned up.

#### 8. New Business

Wildlife Program Discussion – Matt notes that a stakeholders meeting took place on October 31, 2018 with local hunters and a set of safety rules were agreed upon by all hunters accessing the Airport property. No incidents have occurred during the hunting season, and all rules have been followed. No deer have been shot yet; Matt notes that if tags have not been filled by the end of 2018 then additional tags are likely to be obtained by Kent to ensure that deer are removed from the property.

NAV CANADA Weather Camera Renewal – Matt notes that the City has renewed its agreement with NAV CANADA for another 5 years. Dean notes that this camera previously had a heated lens, which is no longer functioning. Dean asks Matt to notify NAV CANADA that the heating element has burned out.

Discussion of Neighbouring Construction Review Process – Dean notes that a 90m tower is proposed approximately 4 miles NE and 2 miles NW of the runway. Dean noted that this tower is outside of the area where the Airport descent minima could be affected. However, as a precaution he has also asked NAV CANADA to review this information. Matt to research the process for if the City or Commission objected to a proposed structure, what the formal process would be to report this information (in the event that a structure was ever proposed within the radii where the descent minima would be affected).
