7. Action Item Update

Heritage Kitchens – Ongoing. Economic Development was talking with another party about renting the hangar space currently occupied by Heritage Kitchens but it fell through.

Apex Helicopters – Ongoing

Airport Fuel Tanks – Ongoing. Received preliminary estimate from W.O Stinson. They did not provide what we requested. We wanted a price on purchase, lease, and fuel purchase agreement with them supplying system. Only priced purchase and said leasing available.

8. New Business

- Reviewed 2015 Draft Operating Budget Paul McMunn reviewed the budget in general. Net operating increase of 3.73% proposed for 2015. Paul McMunn and Wilsie Hatfield reviewed the 2015 proposed budget with the City Finance Department on October 10, 2014. There were no concerns from finance staff and were generally pleased with the proposed budget.
- General discussion concerning the replacement of the batteries for the Non Directional Beacon (NDB). Batteries have a 10 year (estimated) life span. Expense was covered through operating budget – Navigational Aids. Dean Glover indicated that NDB will eventually be replaced with GPS.
- > General discussion on new appointments to the commission for the position held

by Heather Dale Flood and Susan Prettejohn. Paul McMunn expressed that Ms. Floods position could be filled at a later date as it was not imperative to fill it now. Ms. Prettejohn's vacancy would be appointed by Elizabethtown as it is a council position on the Commission.

Paul McMunn to inquire with City of Brockville's clerk's office to determine when term of appointments for positions on the Airport Commission expire.
