Harvey will draft a report for the December 2011 Finance and Operations Committee Meeting proposing the extension the current Airport Operation and Management Contract with the current contractor Brock Air Services for three years at the 2012 price of \$104,868 plus HST with an annual CPI adjustment. This proposed contract amount is based on the 2011 price with a 3% CPI increase. Correspondence was given to the Airport Commission from Andy Bouchard indicating that he would

like to sell his hangar. Per the terms of his lease agreement, the city has the first right of refusal. V Harvey will draft a report for the December 2011 Finance and Operations Committee Meeting indicating that the Commission has no use for the hangar supports the sale to the new purchaser.

Dean Glover is to provide information regarding upgrading the airport GPS system. The report is to provide a brief technical overview and a brief cost benefit analysis.
